

# GOVERNMENT SUBVERSION AGAINST TONY ALAMO

## LOS ANGELES DISTRICT ATTORNEY IRA REINER USES THE CRIMINAL ELEMENT TO BEAR FALSE WITNESS AGAINST TONY ALAMO AND HIS CHURCH

### THIS PERSECUTION CONTINUES TODAY—FROM 1964 - 2013

District Attorney Reiner is an avid user of criminal informers<sup>1</sup> to concoct false cases against innocent people. Another paid police and District Attorney liar, Leslie Vernon White, who was a seven time convicted felon, demonstrated how false confessions and testimonies have been concocted. He said that these practices were widespread in the Los Angeles Police Department and District Attorney's office. By making a few phone calls from a pay phone, he was able to receive enough information about an existing case to fabricate a false confession of an unknowing innocent prospect<sup>2</sup> which, in turn, would get him a weekend leave<sup>3</sup> out of jail from District Attorney Reiner. He said that among the criminal informers the well-used slogan was, "Why spend time, just drop a dime."<sup>4</sup>

A notable defense attorney stated that the criminal informers "don't even need a dime" (to make the fraudulent calls for information to concoct false testimony). He says there are instances where the District Attorney would give criminal informers police case files to review themselves, making it very easy for criminals to concoct a false confession or testimony against someone else (like Tony Alamo and his churches).<sup>2,4</sup>

Many defense attorneys insist that District Attorney Reiner and other Los Angeles prosecutors, such as Lancaster's District Attorney Foltz, have had an organized, formalized system of using unreliable, criminal snitches for a long time. They also stated that they have specific examples that this continues even though District Attorney Reiner expounds differently.<sup>4</sup>

Reiner absolutely refused to talk to *60 Minutes* on his use of bogus informers.<sup>5</sup>

To mention just one of many cases, District Attorney Reiner initiated false charges against Bobbi Fielder (a candidate for the U.S. Senate). She was almost immediately cleared of all wrongdoing by the Superior Court and the charges were dismissed. But in the meantime, because of District Attorney Reiner's false charges, her opportunity to make it into the Senate was obliterated.

Reiner had absolutely no grounds for his false charges against Bobbi Fielder. He was doing no less than smearing a candidate for high office, using the especially deadly poison of felony accusations. He reduced the dignity of the great city of Los Angeles' District Attorney's office to a despicable hatchet job just as he is now doing against Pastor Tony Alamo and his church.<sup>6</sup>

In another case, an ex-policewoman was writing a book about the Los Angeles Police Department. As she was nearing completion of the book, she was arrested in a Reiner-inspired police "sting" and falsely charged with pandering. At her trial, the chief witness against her (a police agent) stated that she wanted to help arrest her to keep her from completing her book. After a brief time in jail, she was out on probation; but District Attorney Reiner argued that she should be given at least three years in prison because her crime of pandering was compounded by having written a book attacking a public institution and public employees. In a brief, Reiner went on record as saying that she should be thrown in jail not only for pandering, but also for daring to criticize the government. (This Vatican government is evil. We must set up a government to protect us from this evil Vatican government).<sup>6</sup>

Regarding the McMartin preschool molestation case, District Attorney Reiner has been accused of "outrageous government misconduct."<sup>7</sup> After years of trial (one of the costliest and longest in history), District Attorney Reiner had to dismiss charges against five of the original seven defendants for lack of evidence. The direct result has been the torture of these innocent people.<sup>6,7,8</sup>

From the beginning of this case, hundreds of felony counts of child molestation were all inspired by the incoherent whisperings of a pre-verbal two and a half year-old child and his mother, a known mental case who later committed suicide.<sup>7</sup>

In 1980, as Los Angeles City Controller, District Attorney Reiner was accused by four different legislators of engaging in a smear campaign against them.<sup>9</sup>

Reiner criticizes and demotes other district attorneys (Prosecutor D'Agostino, Chief Deputy Gilbert Garcetti) who criticize him or run against him in elections.<sup>10,11</sup>

The Republican Party stated that Reiner found political fortune by criticizing the spending habits of other public officials, yet he uses county-paid bodyguards to pick up his laundry and chauffeur him around town at a cost of nearly \$400,000 a year.<sup>12</sup>

In 1980, City Controller Ira Reiner was scolded by the city council for a "major mis-allocation" of twenty million dollars of city funds. To top this off, his error cost the city over one million dollars more.<sup>13</sup>

Reiner was publicly reprovved by the California State Bar for violating rules of professional conduct. He in turn stated, "The bar has a distorted view." Reiner's mistakes, in this incident alone, cost the city an estimated two million dollars. Reiner refuses to show any remorse for his errors.<sup>14</sup>

Ira Reiner's wife is a Los Angeles Superior Court judge (Diane Wayne). Howard Jarvis suggested that Reiner's wife was appointed to the Superior Court bench by Governor Jerry Brown as a "political debt" to Reiner.<sup>15</sup>

One reporter, in profiling Mr. Reiner, commented about his reluctance to ever discuss his personal life.<sup>16</sup> Many of his "inner circle" friends are of very questionable reputation.

A prostitute, whose clients are among District Attorney Reiner's "elite inner circle," stated that it is a common thing for her clients to speak of District Attorney Reiner's **sexual involvements with children!**<sup>17</sup>

Marvin Mitchelson is a good friend of District Attorney Ira Reiner.<sup>18</sup> State Bar Chief Trial Counsel James A. Bascue said, "We have in excess of twenty complaints against Mr. Mitchelson." Mitchelson is presently facing possible disbarment.<sup>19</sup> The California State Bar is also investigating allegations made by two former clients that Mitchelson sexually assaulted them; one involved a claim of rape. A June *60 Minutes* report cited five other women who have accused him of rape or sexual assault.<sup>18,20</sup>

District Attorney Reiner concluded that there was insufficient evidence to prosecute his friend, Marvin Mitchelson. The victims complained that District Attorney Reiner gave Mitchelson preferential treatment.<sup>21</sup>

A Los Angeles County Grand Jury repeatedly requested more investigation into the rapes and sexual assaults and District Attorney Reiner's failure to prosecute Mitchelson. District Attorney Reiner refused the request, and one juror even resigned in protest.<sup>19</sup>

A prostitute, whose clients are among District Attorney Reiner's "inner circle," said that it is a well-known fact that District Attorney Reiner didn't pursue charges against Mitchelson because of their friendship. She said that Reiner is known to protect his friends and political associates who are involved in numerous criminal activities, while fabricating charges against his enemies. She also states that Reiner "looks the other way" in regards to prostitution and cocaine use amongst his "elite associates."<sup>17</sup>

**District Attorney Reiner uses mentally disturbed Lancaster Deputy District Attorney Foltz, who says he issued warrants for the arrest of five Alamo Church volunteers. Foltz's witnesses are all criminals and are known to lie for money. Reiner's and Foltz's purpose is to malign and close the Alamo Church by lying about Pastor Tony Alamo with false child abuse charges. They wish also to inflame the general public with false media propaganda from the District Attorney's office so that people will think that they're doing God a favor by murdering Alamo and destroying the church.**

**This set-up is an old Vatican tactic to get rid of Christians (throw them in the lion's den). Yes, this order has surely come down from the Vatican. Reiner and Foltz are only pitiful little puppets and are doing what they're told by Rome's ambassadors, even though they knew that their careers would be ruined if the facts of their backgrounds and what they are presently doing to Alamo were to be revealed by Alamo's literature.**

**Lancaster Deputy District Attorney Robert Bruce Foltz should be disqualified from his position because of his self-confessed mental breakdown problems and numerous frauds.**

Robert Bruce Foltz is a Deputy District Attorney under District Attorney Ira Reiner.

He is presently under investigation and facing five years probation or possible disbarment by the State Bar of California. In response to numerous complaints brought against him, he has stated in a legal brief that his malpractice was due to his having **"experienced severe psychological implications...resulting in a total mental breakdown."** "He sought psychological counseling and has been diagnosed as suffering from **'Chronic Nonspecific Depression.'**"<sup>22</sup>

He abandoned his private law practice in September 1984, along with all his clients and their cases. He immediately went to work for Ira Reiner at the Los Angeles District Attorney's office and has been so employed ever since.<sup>22</sup>

Foltz is presently the defendant in case No-C-8741 before the Superior Court of the State of California and is being sued for legal malpractice, breach of contract, fraud, and intentional infliction of emotional distress. The plaintiffs are alleging that Robert B. Foltz abandoned their cases while representing them and then fraudulently led them to believe that he was still pursuing their cases for years.<sup>23</sup>

The plaintiffs' attorney, Gerald Fink, alleges that Foltz will not produce documents, show up for his deposition, or even return his phone calls made to the District Attorney's office. Foltz's defense to these charges is to plead insanity and hide behind District Attorney Reiner's office, hoping that the statute of limitations for damages against him will run out.<sup>23</sup> Foltz and Reiner and a few other criminals are manufacturing the story that Tony Alamo is a child abuser. It is our understanding that the District Attorney's office is currently under investigation for using criminals to fabricate stories against citizens in the Los Angeles area.<sup>2,24</sup>

Admitted insane man District Attorney Foltz is the pawn that District Attorney Reiner is presently using to harass and bring false child abuse charges against the Tony Alamo Christian Church by the use of false criminal testimony.

**Louis Tackwood's long criminal record shows the caliber of Los Angeles District Attorneys Reiner and Foltz's witnesses against Alamo. Their own testimonies correspond identically with Tackwood's.**

Louis Tackwood is a former gang member with a long criminal record of over forty-one felony counts against him.<sup>25</sup> He began working as a criminal police informer in 1962.<sup>26</sup> After being busted for auto theft, he was let off to walk the streets on the agreement that he would cooperate with (lie for) the police and District Attorney's offices. The police would supply him with narcotics, guns, and explosives to use in setting people up for busts.

Tackwood is a professional agent-provocateur (a "police agent who is introduced into an organization with instructions to foment discontent...or to fake a case in order to give his employers the right to act against the organization in question"). "Disruption, entrapment, and false information are his daily duties."<sup>26,27</sup> Tackwood also states that one of his employers (Criminal Conspiracy Section of the L.A.P.D.) "spends all its time cooking up false criminal conspiracies against targeted organizations." Tackwood stated that because of his long-time service as an illicit informer and agent-provocateur, the District Attorney granted him a "license to steal," and in one case "to kill" in return for his services. Tackwood admitted that he had fabricated lies on many occasions and had many people sent to jail, some even to "death row" based on Tackwood's lying testimony.<sup>26,27</sup>

Three reporters from the *Los Angeles Times*, *Newsweek*, and *Washington Post* interviewed Tackwood at length and then took him to a lie detector expert to verify his statements. Chris Gugas, Board Chairman and past president of the American Polygraph Association, stated, "The examiner is of the opinion that Louis Tackwood did answer all critical questions truthfully in his examination and that his statements have considerable validity" (in reference to his work and tactics with the police).<sup>26,28</sup>

Tackwood said that the intelligence division of the L.A.P.D. that controlled him also controlled murderers, and if they wanted you DEAD, they would set you up for a hit.<sup>26</sup> He said that in working with the Criminal Conspiracy Section (C.C.S.) of the L.A.P.D., the L.A.P.D. agreed that they would invent and exaggerate minute points and then blow them into a case. He said, "Everybody thinks that (speaking of the department) when you say criminal conspiracy, you mean that they're out to combat criminal conspiracy. But actually they're out to create it."<sup>29</sup>

Tackwood's mouth could be bought for a hundred dollars. Tackwood said, "I have a buddy that I would go to Hell and back for, but I still set him up and got him convicted on a dope sale." There is nothing that he wouldn't do for a price.<sup>26,29</sup>

Tackwood said that the police regularly use phone taps to monitor everyone, and then pick out the lines that they want to individually hone in on. His own phone had an extension running right into the glass house (Intelligence Division of L.A.P.D.). This was confirmed by the reporters investigating his story.<sup>26</sup>

Court documents show that he (Tackwood) has done suspiciously little "hard time," despite his long criminal record of arrest and conviction.<sup>30</sup>

Louis Tackwood was sent into the Tony Alamo Christian Church by District Attorney Reiner and Robert Foltz to fabricate concocted testimony against the Rev. Tony Alamo and his church.

**Subversive tactics of judge and police, says Louis Tackwood; this is echoed in "The Pope's Secrets." Mr. Tackwood says, "Right on!" One-world church Judge Robert Armstrong, friend of one-world church member Governor Deukmejian, conspiratorially issues warrants against Alamo's church; causes vicious police raid on Alamo's church because of false testimony of two other criminals used by the District Attorney's office (Bob and Carey Miller).**

Los Angeles County Judge Armstrong's orders caused many ministers and their wives to be beaten (another example of the Newhall Sheriff's Department brutality). The Newhall Sheriff's Department officials along with the Department of Children's Services tried to terrorize the children into telling lies about the church. One of them did and the rest of them would not under any circumstances. Several other children have been deprived of the liberty to attend the church, the school, services and facilities thanks to this anti-Christian, subversive Los Angeles County judge, the Sheriff's Department, the Department of Children's Services, and, of course, the Los Angeles District Attorney's office.

Judge Robert Armstrong's father was the Chief of Police in Huntington Park, California.

Judge Armstrong was once a defense attorney in Huntington Park.

He's an active member of the Episcopalian (one-world Catholic) church and a long time friend of Gov. Deukmejian; the two of them are lay readers of the same church.

He was appointed to the Superior Court bench in 1985 by Deukmejian (after Deukmejian became governor).

Judge Armstrong has yet to establish a good reputation among lawyers, and some who have appeared before him feel that "...his weakness is that he's not up on the law..."<sup>31</sup> And now this Episcopalian (Catholic one-world) communist judge issues false warrants against citizens at criminals' request.

Part of this one-world conspiracy against Christianity belongs to Orange County Judge Ronald Owen, an advocate of anti-Christ Sigmund Freud and Pope John Paul II (who lauds the anti-God teachings of Sigmund Freud—psychiatry/psychology). Judge Owen issued the order to remove the three children from the church and also issued temporary custody to the two criminals Bob and Carey Miller.

Orange County Judge Richard Frazee, another conspirator, issued the decree that the mothers of the children could not come within 200 feet of their children. All the conspirators play the game of conspiracy as well as the San Francisco 49ers play football. They all play their positions very well. These illegitimates do their best to make everything look so legitimate.

The news media constantly berates the Alamo Church by using typically subversive blast words such as "compound," "cult," "brainwashing," "child abuse," and other derogatory one-world church, customary propagandistic slurs. By now, everyone should be able to see the conspiracy of one-world church government and media to destroy Christian fundamentalism and American patriotism.

Hundreds of other notarized testimonies are available at your request, including those of Bob and Carey Miller and their mother Gerry Miller praising the works of the Alamo Church.

Also available is a forty-four page color pictorial magazine of the facilities of the Tony Alamo Christian Church.

In ordinary times, it would be hard to figure out why the American government would try to destroy good works like the Alamo Church. But now, it should be very clear why the subversive Catholic communist I.R.S. would give tax-exempt status to every

communist organization in the U.S. This fact can be found in their own tax code books for the duration of the time that the I.R.S. has been citing our pro-American, anti-Catholic communist, anti-Satan church.<sup>32</sup> The Internal Revenue Service has made another wild and erroneous statement that I have tried to put off their kangaroo-court hearing (no jury, only an I.R.S. judge) by firing all my attorneys at crucial points and not paying them. The facts are the exact opposite. These attorneys took huge sums of money from our church and then made unreasonable financial demands that the church could not meet. The attorneys dropped us after we had paid them hundreds of thousands of dollars. This is proof to us that the pro-communist I.R.S. has also subverted our attorneys. The attorneys figure they've gotten their money so why should they lock horns with an anti-American terrorist group such as the Internal Revenue Service.

1) The Internal Revenue Service courtroom does not allow a jury trial. 2) The I.R.S. does not allow Bible scripture to prove that we are Christians. 3) The I.R.S. does not allow the U.S. Constitution. They say, like Father Bernard Leeming, that the Constitution is irrelevant. Father Bernard Leeming, a member of the Jesuits, said, "To Hell with the U.S. Constitution."<sup>33</sup> The I.R.S. has made up their own Bible and everyone that does not go along with Catholic communist Roman canon law is unscriptural. (For example, the I.R.S. says if you don't bum money, you're not a Christian. But the Bible says if you don't work, you don't eat [2 Thes. 3:10]).

Today's attorneys all admit that they are not taught nor do they practice United States law any longer. Most attorneys say that they are owned by the state, and have sworn their allegiance not to their clients but to the state. They learn and practice only international law, which is one-world government (U.N. law). The United Nations was founded and is controlled by the Vatican. Your children have been taught in school exactly the same way. I tell you that the communist doctrine that you are living under is ANTI-CHRIST. The anti-Christ I.R.S. constantly smears Alamo through Catholic communism's propagandist arm (the news media) and pays false witnesses (criminals), then takes Alamo's tax exempt status away and tries to drain this worthwhile, very effective, struggling church of millions, taking away everyone's home and livelihood at the church.

Our Church wishes to cross-file on the Internal Revenue Service for its contrived harassment. It has cost us millions of man-hours and over a million dollars. And now district attorneys everywhere will issue orders to the police departments to

arrest church people for distributing this literature because they don't believe in the freedom of the press, the freedom of religion, and the freedom of speech, and the judges will all rule according to Roman canon law. They would not be one-world order Catholic communist judges otherwise. The conspirators and the big boss in Rome would make sure of that.

## **AFFIDAVIT FROM A FORMER JAILHOUSE INFORMANT WHO INFILTRATED THE TONY ALAMO CHRISTIAN CHURCH**

I, Louis Tackwood, have been living at the Alamo Christian Fundamental Church for about one year. In all this time, I have never personally seen or heard of any child abuse, but I have seen deep love and devotion for all the children, both the ones living here and all the children who visit the church. This is why I was proud to have my son, Jason Tackwood, age nine, until the morning of March 30, 1988, when the police invaded our church property with what they said was warrants for my fellow ministers on the false charges of child abuse.

The following statement is a true account of what occurred on that morning to myself and my son at 6:30 a.m., March 30, 1988. A fellow minister informed me that the police were on the church property, so I got up out of bed (I sleep in one of the dorms on the church property), put my clothes on, and started to wake my son up (he had been spending his Easter school break with me at the church). At this time the handle on the door started to turn. I looked up because my bed is the first one facing the door. The next thing I knew, the door was kicked open and a large police with a 12 gauge shotgun was standing there. He cocked the shotgun and said, "Welcome to the party, will you join us outside?" I asked him, could I get my son up. He said, "No," and leveled the shotgun at me and told me to get out and over to the others. When I came out, I saw about six to eight police officers with shot-

guns and cocked pistols all pointed at two groups of my fellow ministers of the Gospel. One of the police put his hands on my neck and pointed his gun to my head and told me to put my hands on a car.

About five minutes went by and the police sent my little boy over to the car where he had to put his hands on it too. We stood there for 15 minutes. It was very cold and my little boy was shaking.

The police finally told all of us to go into the church. When we got there, I was made to sit in one place, my little boy another. The police kept questioning my little boy, but all he would say is he wants to sit with his father. They finally called me over to where they had him sitting (about 20 feet from the rest of us).


When I sat down, the policeman who seemed to be in charge informed me they were taking my son somewhere else. I asked them why. He said for his protection and safety. I told them he was safe with me. My son also stated he didn't want to go anywhere with them. I protested again. My son said, "Daddy, where are they taking me? Are you going?" The officer said your daddy's going to jail. At this point, they made me move back to where the other ministers were being kept. About ten minutes later a lady police called me out of our group and told me she was taking my son to another location. I protested again. My son called me. They told us to be quiet. They took him out to our other property

where they made him undress and asked him what he called "stupid questions." "How many times were you spanked with a paddle? Did it hurt?" These questions confused him because he has never been spanked with a paddle in his life and doesn't understand what misuse is.

Later that night he was so upset because he thought they would come back and make him undress again. I had to take him back to the city where he lives.

I have been at the church for some time, and I've never seen any child abuse. These charges are unfounded and there must be something done about these charges and this constant harassment on my church. I've committed no crimes but rather only preach and teach the Word of God, the King James Version of the Bible.

The only act of child abuse I have ever seen occur on our church property at any time, was on the morning of March 30, 1988, when an army of police raided our church and without regard for our children's feelings, stripped them naked and mentally abused them with false and misleading questions; and the bottom line—they found 20 happy and well treated children. They left 20 confused and frightened ones.

## **FEDERAL AGENT CONFESSES GOVERNMENT PLOT TO DESTROY THE ALAMO'S CHURCH**

### **Joseph Taliaferro's Confession**

My brother is a cop and I used to work undercover with the police department and help bust drug dealers. The National Aviation Facilities Experimental Center

(N.A.F.E.C.) located in Pomona, New Jersey, hired me to infiltrate the Tony Alamo Christian Church. Agencies like this plant it in your heart and soul not to

talk about working for them, under any circumstances, even under threat of torture. I was to be paid \$10,000 for information that I would supply to the N.A.F.E.C.

I believe that the N.A.F.E.C. is a division of the FBI and the U.S. Department of Labor. Also, it seems to me that they are somehow linked with the Mafia. I was instructed to call in several times per day to talk to the men who hired me, Captain Connelly and Lt. Robinson, who could be reached at (609) 641-6100.

I was hired at the time that the Tony Alamo Christian Church came to Atlantic City about the abortion issue. The N.A.F.E.C. told me that they were merely interested in the anti-abortion program that the church was offering. At this time I couldn't understand why, but the church was offering free aid to women that were going to have an abortion, if they would agree not to have the abortion. The church was offering free prenatal care, hospitalization, and support for the mother and child. Why they wanted me to place myself secretly into the church at first seemed innocent enough, but the plot got thicker as the time went on.

The N.A.F.E.C. wanted to know many things about the Tony Alamo Christian Church, even the complete layout of Tony Alamo's house and even the room he slept in. They also wanted to know the doctrine of the church. Tony showed me throughout his house and even the room where he slept, which was a small room. The United States Federal Government even wanted to know if Susan Alamo was really dead. It seems kind of crazy to me, because hundreds of people were at the funeral and the casket was open, and she died at the City of Faith Hospital in Tulsa, and was embalmed there before being brought into Arkansas. I'm told there is a death certificate, and her casket was left open for two weeks. To me, the doctrine of the church is very beautiful and scriptural. The people at the Tony Alamo Christian Church go to two services every day. They read the Bible and pray. I was truly inspired myself.

There were several sequences of events that transpired while I was at the church. They were all being done by the Federal Government. First, a branch of the government sent many false telegrams while I was at the church stating that I had inherited two and one-half million dollars. I was instructed to show these telegrams to the people at the church and to tell them that I wanted to tithe some of it

and then invest the rest in business. This they told me to do in hopes that I could get close to Tony Alamo. The next sequence of events, which I knew nothing of, was that the Federal Government had some men call the church stating that they were going to kidnap me, knowing that Tony Alamo and the church would try to protect me. There was yet another sequence that I didn't know about. I don't believe that the people that were calling with the fake kidnap threats knew about it either. Helicopters started flying over the house, which I believe were military helicopters. Several Jeeps were seen around the area loaded with what I believe were Federal men. Also a silver and blue van with five large men was seen at the Alamo Grocery Store in Alma. Local police force vehicles were seen prowling the area.

Because of the vicious nature of the Federal Government Agency that I was working for as a spy, I personally believe without a doubt that they are deliberately trying to make the Tony Alamo Christian Church look like a bad and mysterious organization which it is not. I have seen literally hundreds of letters commending them for their kind work. I have personally sat in one service after another and heard wonderful testimonials from the church people. I have become very well acquainted with many people who live at the church and they are all beautiful people. While I was at the church I saw the sincerity of this church and found it to be a very good church, preaching the gospel of the Lord Jesus Christ in a very convincing manner and helping the poor, suffering, and needy. I believe that this is what churches are really supposed to do.

Because I am giving this testimony, I fear for my life. These Federal government agencies are very vicious and will pay thousands of dollars for false testimonies against the church. They are looking, at any cost, to destroy this church and any other church like it. These federal agencies most certainly hire and work with hardened criminals and are inspired exclusively by the Vatican.


I believe that the U.S. Government was setting up the Alamos for slaughter. The fake kidnap threats would have the Alamos thinking that they would be protecting me from goons. The Feds were

They have told me that they planted six other agents in the church who have been there a year or more. Also, they say that they will be sending a girl in with a \$100,000 donation. Isn't it something that these people have been there for a year or more and still have not found anything wrong with this wonderful Christian church?

Again, I fear for my life. I just hope that all Christians that really know God really pray for me. I am leaving the church because of the conviction of God that I am under. The Tony Alamo Christian Church has done nothing but good to me and I returned that with bad.

# THE TRUTH ABOUT TONY ALAMO AND HIS CHURCH

I, Scott Gregory, am exceedingly grateful for the mercy that the Lord, through the Tony Alamo Christian Church has bestowed upon me. My own mother would not allow me to stay at her home because of my belief in Jesus Christ and because I wanted to read the Bible (she's a Catholic). My own mother placed me in a home for the emotionally disturbed. The name of the institution is called Brandon at Petersham, in Massachusetts. It was nine years that I stayed there.

Every week, Channel 40, a Fort Smith, Arkansas television station, called me at my mother's home, telling me numerous lies and slanderous remarks about Tony Alamo and the Tony Alamo Christian Church. No wonder I was confused. They began bribing me with hundreds of dollars, fancy hotel rooms, steak dinners, chauffeured cars, and Channel 40 even gave me carte blanche at the cocktail lounge, which I refused. It was a dizzy round of events. One of the lies Channel 40 told me was that Tony Alamo, in a front page article in the *Southwest Times Record*, called me all kinds of names. Channel 40 would not let me see the article but said I should go to the District Attorney's office (the D.A.'s name was Ron Fields) and file a trumped-up kidnapping charge on Mr. Alamo and associates. Davis Woods and Keith Fry, Channel 40 representatives, drove me to Ron Fields' office.

Before this, when I was at my mother's home in Massachusetts, Davis Woods from Channel 40 called me and told me that I could really get Mr. Alamo and the church on this kidnapping charge and that I could call the District Attorney, Ron Fields, collect, and that he would be waiting for my call. Davis Woods mentioned to me the Little Lindbergh law. I didn't even know what the Little Lindbergh law was, or the penalty that it carried until later when I talked to Jack Jewel from the FBI office who was investigating another false charge, that Pastor Alamo was fixing the votes in Dyer, Arkansas. Because of the lies that Davis Woods from Channel 40 said Mr. Alamo told about me in the front page of the *Southwest Times Record*, I was hopping mad. Mr. Fields was not in, but his secretary gladly accepted my call.

When I got back to Arkansas and after I had pressed charges, I went to the library to try to find this article in the *Southwest Times Record*, and when I found it, my heart sank because all the things that Channel 40 representatives Keith Fry and Davis Woods said were false.

While I was filing these false charges against Tony Alamo in Ron Fields' and Lee Kuykendall's (district attorneys of Sebastian and Crawford County) office (a deputy sheriff was also present), they were very happy and excited to file charges against Mr. Alamo and the church. At this time, Ron Fields bragged to me that he was the one that called the FBI in on the phony Dyer election scandal that he caused, and tried to get me to be afraid of the only person that has ever been decent to me and treated me fairly in my whole life, Tony Alamo. My bed was assigned to me in Dyer at one of the dorms and I was in Dyer every day of my life for 2 ½ months before the voting.

When Channel 40 put their trumped up interview with me on the air, which was a three day, hour long TV series which they called "Mystery on the Ridge" (the ridge, Georgia Ridge, is just above Dyer, Arkansas), they said that I had given them the names of people that did not live in Dyer that voted. This is not true. All the people who voted in Dyer lived there, so how could I have given them any names that voted that didn't live there? I never gave them any names at all.

After reading the newspaper article in the library, I was very sad and troubled and felt that I had been used by Channel 40 and the District Attorney, Ron Fields. It chilled my blood when I recalled back that Mr. Jewel from the FBI office told me that kidnapping, (the Little Lindbergh law), carried the death penalty. These district attorneys, Ron Fields and Lee Kuykendall actually want to see Mr. Alamo dead.

Also, Channel 40 hates Mr. Alamo, because he knows they're liars and won't let them have interviews because of their lying smear campaigns during the time of Susan Alamo's death and that they made mockery of her at the time of her funeral and his mourning. So I called up the D.A., Ron Fields, and told him that I wanted to

drop the false charges, that the things that Channel 40 had said about Mr. Alamo were not true, and that they were all false charges anyway, that no one had kidnapped me. Ron Fields encouraged me not to drop charges even though I demanded him to. He argued about this with me very much. This made me afraid, and I hung up. I could easily see the hatred that Ron Fields felt for Mr. Alamo.

After being in the church and being out, it is frightening to see how people lie and twist things and confuse the public in their quest to destroy the church.

Channel 40 even brought me to the U.S. Department of Labor's office, instructing me to go to the U.S. Department of Labor and help them in their quest to try to destroy the church (but they never will). Roland Shell of the U.S. Department of Labor also made slanderous, degrading remarks about Mr. Alamo's deceased wife, Susan. They also instructed me to call U.S. Department of Labor attorney, Robert Fitz, in Dallas.

While I was at the Tony Alamo Christian Church, I was hateful and didn't really keep up my share of the work and wouldn't go to all the prayer meetings or read my Bible enough. At that time, I deserved to be dismissed from the church.

I praise God that I'm back at the church. I praise God for His mercy, that God has opened my eyes to the tremendous amount of wickedness in these small Arkansas communities, wickedness that is directed against a mighty work of God that is winning thousands of souls every month, saving hundreds of men, women, and children's lives, feeding and clothing and visiting people, opening its doors to strangers and having mercy by welcoming back the prodigal son.

I understand that Ron Fields is now saying on TV that he advised me to wait a day to think it over before I press charges. This is not true. He never told me any such of a thing. What he did tell me was that Mr. Kuykendall was not in his office, because it was late in the afternoon, and instructed me to be sure to be back at 9:30 in the morning.


Channel 40, Ron Fields, and Lee Kuykendall are the ones that persuaded
