

# **Uhlelo Olufinqiwe lwe-Investigative Journal Radio noGreg Anthony kwi First Amendment Radio**

Agasti 7, 2014

UGreg uqala ngokuthi uTony Alamo usetilongweni kusukela ngo 2008 iminyaka engu 175 ngamacala aqanijiwe okuhlukumeza ngokocansi, kanye nendlela uTony, eminyakeni ewu 40 kuya ku 50, akade esitshela ngayo iqiniso mayelana ngamandla eSigodlo (i-Vatican - okuyisigodlo samaRoma aKhatholika) phezu kwenkululeko yethu yenkolo nendlela yaso ekhohlakele futhi enobusathane yokungena kwinqubo yethu yezombusazwe. Uchaza ngendlela uTony afinyelela ngayo kuzinkulungwane ngezinkulungwane zabantu emhlabeni wonke nalendaba yokuphikisana neVatican, okuyindaba okumele ikhulunywe ngoba kunobufakazi obubonisa ukuthi uTony ukhulumu iqiniso, futhi uye wahlushwa, wacindezela ngenxa yalokho.

UGreg ukhulumu ngokuhlasela kwango 2008 kulenkonzo e-Arkansas, ethi kwenziwa ngendlela efana nokuhlasela okwenziwa eWaco. (Ngonyaka ka1993, abezomthetho bahulumeni wa-seMelika (ama-federal agents) bahlasela umphakathi othile owawusolwa ngobugebengu endaweni yase-Waco eTexas, lapho kwafa futhi kwalimala abaningi.) Uthi wezwa ngalokuhlasela okwenziwa enkonzwensi, emithonjeni eqavile yezindaba, futhi kwakubonakala ukuthi abezindaba babazi kabanzi ngalokuhlasela. Ucabanga ukuthi inhoso yabo kwakungukuvala lenkonzo enempumelelo enku, futhi enamabandla ezifundeni ezahlukene, kanye nokuzingela uTony. Indlela abenza ngayo kwabangkuhlasela abantwana bakulenkonzo. Uyalandisa ngokwashiro wumbali weblog mumbe (i-blog - okuwuhlobo lwe-webusaythi lapho kubhalwa iziqeshana zezindaba nemicabango njalo njalo njengaku-dayari), mayelana nalenhlasel: ngesikhathi abezokugcinwa komthetho esizweni nesifundaze eMelika begasela enkonzwensi, eTony Alamo Ministries, abaningi, uma kungasilona iningi, abaningi bemithombo yezindaba abaqavile babes-Texarkana, e-Arkansas, bebuka konke kwenzeka, kodwa bengabhali lutho ngakho kwaze kwaba sekuqaleni kwayo inhlasel. Ngokusobala, babazi ngakho konke lokhu. Lenhlasel kwakukade kuhlelelwe ukuba yenzeke ngo-Okthoba, kodwa, yaze yenzeka ngoSeptemba. NgoLwesihlanu, ngosuku olwandulela lokuhlasela, omunye ehhovisi loMmeli omkhulu waHulumeni eMelika (kwi-US Attorney's office) wathumela i-imeyli ngalenhlasel engaqondile emahhovisi abezindaba angaphezu kwa 50 esifundazweni sonke. Leyo imeyli yathunyelwa kusasele amaviki amaningana ngaphambi kokuba kufike usuku olwalumiselwe lenhlasel. UGreg ukholelwa wukuthi lokhu kwakuyicebo lokulahla uTony ngecala, ngaphambi kokuthi lithethwe ngokukholeka.

Umbhali wamablog okuthiwa nguFrank Lockwood wathi: "Kwathi ngokuchakwa nokudalulwa kwalendaba, abezomthetho baphuthuma bafinyenza isikhathi esasimisiwe. Amaphephandaba kwadingeka ukuthi akhethe phakathi kokufaka lendaba emaphepheni angomgqibelo noma alinde usuku noma ezimbili. Ngenxa yemibiko ngezingane ezazisekhona esontweni, kanye nangenxa yezinsolo zokunukubezwa kwezingane, zonke izinhlangano zabezindaba esizweni zazikhethela ukuhoxa ukubhala ngalenhlasel kuze kube seyiqlile." Benza ukuba abezindaba babe magange, futhi bakuthakasele lokhu; akekho owazi ukuthi kwenzekani ngempela. Kuyisigwebo esibuhlun-gu indlela lenhlasel eyenziwa ngayo ongathi baqotha izinswelaboya ezinodlame (kwensiwa 'in a swat like fashion'). Uchaza ngendlela iqembu lezabokulwa nodlame elafika ngayo liphe-the izibhamu ezahlukene, lazethusa kabi izingane ezabe zidlala ngaphandle, lizama ukubopha uTony, kanti uTony wayengekho nalapho, kodwa wayese-Los Angeles ngalesosikhathi. Zazin-gekho izinkomba zokuthi kwakukhona izikhali noma ezinye izinto emagcekeni asesontweni.

Kwakuyinhlangano enokuthula, futhi uma babefuna ukubopha uTony, babengakwenza ngendlela enokuthula, kodwa bakwenza ukuthi kube nokubukisa kwabezindaba, futhi kube yindlela yokumlahla ngecalia ngaphambi kokuba lithethwe icala lakhe ngendlela efanele.

Izingane eziyisithupha zathathwa zagcinwa kwabezenhlalakahle besifunda ngalolosuku. Ngosuku olulandelayo, indaba yakhishwa kuyo yonke imithombo eqavile yezindaba. Kwenziwa umkhankaso kwahlaselwa ezizinden i zebandla ezweni lilonke, ngaleyondlela kwaba ukumgweba njalo uMnumzane Alamo. Lendaba yavela nasohlelweni luka-Oprah Winfrey kanye nakwezinye izinhlelo ezinkulu zikamabonakude eziphathelene nobugebengu.

UGreg uthi ngokubona kommeli, abezomthetho abanalutho oluphathekayo kulendaba, kanti futhi kwanaloko abanako, kungenzeka ukuthi kwabe konakele, kungasenamsebenzi. Lena yin-qophamlando yecala ukukubonisa ukuthi bangenzani kuwe uma umelana neBandla lamaKhatholika kanye neSigodlo (i-Vatican). UGreg uyaphawula ngendlela i-Melika enokuzenzisa nokuba nxambili (i-double standard) ngakhona, ukuvumela amabandla e-Vatican ukuba aqhubeke asebenze emva kobufakazi obuningi, ngalokho okwenzeka ezinganeni ezikoleni zamaKhatholika e-Canada, e-Ireland, ukuhlushwa kanzima nokuhlukunyezwa emhlabeni wonke, futhi sisavumela lelibandla ukuba lisebenze?! Banemali namandla kanye nokulawula uhulumeni wethu ukuze bakwazi ukuphunyuka bangajezi ngokuhlukumeza izingane. Uma unezwi elikhulu njengelika Alamo, bazokuzingela, bakubeke amacala afana nawabo bese besebenzisa abezindaba, i-FBI, abezokugcinwa komthetho, imvalamlomo (ukugwazisa), kanye nokuphoqa abantu ukuba bakubeke amacala amanga bese kuthi emva kwesikhathi bawahoxise. Ukhulumu ngecalia lombango (i-civil case) ngoMashi kanye nesahlulelo esiyingxeny yebhiliyon yamadola (\$500 miliyon).

UGreg uchaza uTony njengomuntu oneminyaka engu 79 futhi oseyimpumputhe esejele. Aphinde adlulise lokhu okushiwo nguTony esejele: Sekucishe kuneminyaka engu 50, bezama ukungivalela. Okokuqala, basisola ngokuba amakhomanisi, basihlukumeza futhi basivalela ejele ngonya, thina kanye namalunga ebandla lethu, babezama ukusivala, nokuvimba unkosikazi wami uSusan kanye nami ukuze singalishumayeli iqiniso ngeZwi likaNkulunkulu. Base befuna ukuba sibe yiWaco, futhi baqhubeke nokusisola ngokuthi siyinkoloze eyingozi kanye namaphekula ahломile. Ngaphinda ngasolelw ukuhlukumeza izingane, okwathi ekugcineni lawomacala ahoxiswa nguMshushisi Wesifundaze sase Los Angeles (i-District Attorney). Base bengithwesa elokusonga ukuthumba ijaji likahulumeni ophethe ezweni (i-federal judge). I-jury (abasizi bejaji) yangithola ngingenacala. I-IRS (Abekokuqoqwa kweNtela) yabe seyisetshenzisa ukwakha icala elingekho lokuthi angikhokhi intela emholweni ongakaze ubekhona. UMMeli wami, uJeff Dickstein, umbhikishi wentela, wabekwa esimweni sokuba anginikele noma kuye yena etilongweni. Ngagwetshwa iminyaka eyisithupha, ngenxa yokuziphatha kahle, ngaphuma ejele emuva kweminyakeni emine ngo 1998. I-FBI yaqhubeka nokungiphenya ngokungakhathali. Ekugcineni, ngo 2008, bathola ofakazi bamanga abambalwa ababeshiyile enkonzwensi eminyakeni edlu-ukuba bavume ukusebenzisana nabo. Isithembiso sokuthola isinxephezel kanye nemali ecaleni lombango kwakuheha kakhulu. Icalia lombango (i-civil case) lasebenzisa ofakazi abafanayo abayisihlanu kanye nowesithupha, naye owayekade eyilunga owasetshenzisa nasecaleni lobugebengu, ukuqinisa icala. Kodwa kulesikhathi esetshenzisa ecaleni lombango, wayefuna ukuthola umklomelo wemali, ngakho wasungula icala elisha lokuthi wayeqeqeshelwa ukuba wunkosikazi kodwa waphunyuka kuqala. Owesikhombisa wayesenkonzwensi kwaze kwaba nguJuni, 2010, wabe azi ukuthi anginacala futhi engeseka emva kwecala. Wahamba ngoJuni. Ngo-Agasti, wahlanganyela kanye nabangibeka icala lombango ngenxa yokufuna imali. Icalia lombango lalisenkantolo enkulu yesizwe (i-federal court), kodwa sekusondele isigwebo, ekugcineni ijaji lak-

huluma ngezicelo neziphakamiso ezazikade zifakiwe, izicelo zokuthi lehlulelw ngokufinqiwe icala, futhi wonke amacala ayebekwe phambi kwenkantolo yesizwe ahoxiswa. Ngakho-ke icala lavalwa laselifikwa kabusha enkantolo yesifunda e-Arkansas. Ijaji lavumela ukuthi wonke amacala ebeliwachithile enkantolo yesizwe abuyiselwe futhi enkantolo yesifunda. Sasingasenayo imali yokuphinda silwe lelical, ngakho-ke sahlulwa kanjalo nje.

UGreg wathi bahlasela uTony kanye nebandla lapho kuzwela ngakhona kakhulu: ezinganeni. Bassha wonke amabandla nezinkonzo zakhe befuna zonke izingane ezazingathathwanga ngenhlasel yokuqala. Uchaza inhlasel yokuqala eyabe inamaphoyisa ayikhulu, ithimba lokulwa nodlame, kanye nangendlela abathatha ngayo izingane zamantombazane eziyisithupha zidlala kozwingi. Akukho neyodwa kulawo mantombazane okwatholakala inento engalungile ephathelene noTony. Bazithatha ngendluzula bezithwele ngezingqola, ngalesosikhathi amantombazane, ayecka amaculo okholo.

Wachaza ngezingxoxo zophenyo olujulile ezenziwa ngosuku olulandelayo namantombazane, nangendlela abangatholanga lutho ngakhona. Nokuthi enye yabe ingudadewabo womuntu omdala owayehlala lapho, kodwa abavumanga ukuyibuyisela kubazali bayo. I-DHS (iDepartment of Homeland Security - okunguMnyango ophethe ezokuPhepha Ezweni) yawagcina amantombazane ayisithupha, noma ngabe bengatholanga lutho olungalungile, ijaji lase likhipha isimemezel sokuthi kulandwe zonke izingane zasenkonzwensi ezindaweni zonke zaseMelika. Abazalwane babaleka nezingane zabo ukuze baphephe—okwaba indlela kanye yokuhlakaza konke. Uphawula ngamaveni amabili ayethwele ezingane amiswa emgwaqeni omkhulu. Abezomthetho bahlwitha izingane kanye nabantwana bangazibuyisa. UGreg wathi lokho kwakungukuthumba. Ugcizeleta ukuthi abatholanga lutho olubi olwenziwa ezinganeni, futhi akukho okwatholakala okumelene noTony ababengakuse-benzisa ecaleni lakhe, njengoba babethemba. Babazi ukuthi kuyindlela yokubhidliza inkonzo yonke. UGreg uyabuza ukuthi ingabe leli yizwe lamaGestapo na. UGreg uthi lokhu kwenziwa ukuze kuvalwe inkonzo, ukuvimba uTony ukuthi angakhulumi okumelene neVatican, kanye nokuthatha yonke impahla kanye nemali kaTony. UGreg uyabuza, “Kungani bengathathi yonke imali yeVatican ngenxa yakho konke abakwenzile?” Kwakunecala lasenkantolo ngalokhu kodwa bathi, “ISigodlo asinamabhizinisi esiwenza eMelika.” Bazama ukubhidliza inkonzo ngokuhlakaza abantu abahlela umsebenzi ngaphambi kokuba uprintwe, abaprintayo, kanye nabasabalalisa izincwadi, kanye nalabo ababenza ukuba inkonzo iqhubekele emadolobheni aseMelika masonto wonke, besabalalisa izincwadi futhi beziposa. UGreg wachaza izincwadi njengalokhu akhuluma ngakho ohlelweni lwakhe, amandla eSigodlo phezu kwenkululeko yethu yezenkolo naphezu kukahulumeni wethu, futhi bezama ukwenza ukuba bonke abantu bakholwe wukuthi yibona ibandla elilodwa leqiniso. Uma kwakune nkoloze, yiVatican uqobo! UGreg wathi abazali kwakumele bakhetha kabuhlungs ngokwesabekayo phakathi kokushiya inkonzo noma ukulahlekelwa yizingane zabo, futhi baphinde balahlekelwe amalungelo abo okuba ngabazali. Isibhicongo nencithakalo eyadaleka phakathi kwezingane nabazali ingelinganiswe. Izingane zase zigcwaliswa ngenkohliso ngokuphelele ukuze zibone abazali bazo njengezitha, zibazonde, zizonde nenkonzo ebezikade ziyithanda ngaphambilini.

Umbuzo owabuzwa nguTony esejele uthi: “Lapho kukhona ubufakazi obuqandula ikhanda bo-kuhlukunyeza kwezingane kwinkoloze yamaKhatholika, kungani abantwana bengavinjwa ukuya ezikoleni zabo, ezinkonzwensi zabo, emakhaya abo ezintandane, ezigodlweni, njll? Kungani abazali bamaKhatholika ababuyisela abantwana babo kule nkoloze ehlukumeza izingane nsuku zonke, bengazitholi bebhkene nesimo sokulahlekelwa amalungelo abo okuba ngabazali nokuthi izingane zabo zidunwe, zithathwe?”

UGreg wabe eselanda indaba ngomama wakhe owashona ngenxa yesifo somdlavuza wegazi ngesikhathi umfowabu owayezalwe kungakafiki isikhathi, wayenezinyanga eziyisithupha kanye

nobaba wakhe owayenezikweletu eziningi okwakumele azikhokhe. Kwakukhona indawo yezin-tandane yamaKhatholika eyayingekho kude nalapho ayehlala khona, lapho babeletha khona bonke lababantwana.

Isikhulu sasemaRomeni safika endlini yakubo, kodwa esikhundleni sokuletha usizo kuba-ba kaGreg, sasifuna ukuthatha izingane kubaba wakhe, ukuze sizifake endaweni yeziintandane yamaKhatholika. Ubaba wakhe wabamba isikhulu leso wasijikejela odongeni, wasithuka, wasikhahlela esehlisa ngezitebhisi. UGreg wathi, “Yilendlela engizizwa ngayo ngeVatican. Bakhahlele ezinqeni bese uyabaxosha endlini yakho. Yilokhu okwenziwa ngubaba wami, futhi sakhula siphile saka futhi sijabulile, kanti umfowethu ungsomabhizinisi onempumelelo kakhulu njengamanje.” Ubaba wakhe wafunga ukuthi angeke aphinde alubeke unyawo lwakhe ebandleni lamaKhatholika futhi akaphindanga waya. Akazange futhi ahambise umfowabo esikoleni samaKhatholika. Ubaba wakhe wacela ukuba uGreg amvumele ukumkhipha esikoleni samaKhatholika, kodwa uGreg wamncenga ukuba amyeke ahlale khona ngenxa yokuthi abangane bakhe babelapho futhi wayesanda kulahlekelwa ngumama wakhe.

Engxenyeni yesibili, uGreg ukhulumma ngamajele uTony abe kuwo, echaza izindlela abazihlo-la ngayo zonke izingxoxo zakhe nakho konke ukuxhumana kwakhe nabanye, kanye nendlela abaqaphela ngayo ngezikhathi zokuvakasha; akukho okufihliweyo. Uhulumeni wakhokhela iCult Awareness Network (Abaqaphela iziNkoloze) ngaphezu kuka \$5,000.00 ngofakazi ngamunye ngalabo abathathu ababefakaza bemelene noTony isikhathi esingamaviki amabili, lapho babe-matasatasa bebakhipha ulwazi oluhle ngoTony, bekwenzela endaweni esemaphandleni okuthiwa yi-Wellspring Retreat. Uhulumeni wakhokhela uhambo lwabo futhi wakhokhela umntwana wo-munye wofakazi u \$1,500.00 ukuze abhekwe ngesikhathi umama wakhe esayolulekwa. Bakhok-hela ofakazi besebenzisa izaba zokuthi angeke bakwazi ukukhokhela izikweletu zabo ngesikhathi bese lapho, izinto ezifana nomshuwalense wemoto, njll. Owayengumphathi eWellspring, uPaul Martin, wasebenza nalabofakazi yena qobo lwakhe. Lokhu kwenziwa ngoDesemba ka 2008, futhi masinyane emva kwalokhu uMnu. Martin wagula, watholakala enomdlavuza wegazi futhi wabe eseyashona ezinyangeni ezimbalwa.

Ngaphambilini, ubufakazi balabo ababefakwe ohlelwani lokususa izinto ezinhle abazazi ngo-Tony eWellspring abamukelwanga enkantolo. Kodwa uma omunye wabasiza ummangalelw-a (ilunga le-defense) engatholakala ezama ukukhulummanofakazi, wayengabekwa icala lokuphaza-misa ufakazi. Nokho uhulumeni uyawkwazi ukuthatha ofakazi kalula nje abahambisa kulendawo ukukhhipha ulwazi oluthile. Abantu bahamba mhlawumbe bengaseki muntu, beluvivi, babuye sebeyimpi yodwa, benobutha obukhulu. Lokhu kuyiphuzu elibalulekile kulelicala.

Wathi, uDorothy Curry wabeka ngokusobala ukuthi abaphathi bohlelo, *Izimfihlakalo Ezingaxazululiwe* baqamba amanga, washo nanokuthi uTony Alamo akayihlukumezanga intombazanyana yakhe. Lokhu kwakungo 1991 ngesikhathi bezama ukwenza okufanayo kuTony, ngokungenayo impumelelo. UGreg wafunda okunye okwashiwo nguDorothy, ezincwadini lapho ephikisa khona izinsolo ezabekwa nguJim Griffin zokuthi uTony wahlukumeza uCarissa.

UGreg wafunda indatshana ebhalwe encwadini yezindaba ebizwa nge-Protestant Mission Newsletter yase-British Columbia, eyayisho ukuthi abafowethu basenkonzweni bahamba kan-jani ukuya eCanada kanye nokuthi basabalalisa kanjani izincwadi zeVangeli ngesikhathi uPhapha uJohn Paul II wayemiselwe ukuvakashela khona. Ngosuku uPhapha afika ngalo, abafowethu baboshwa. Awekho amacala ababekwa wona, asikho isizathu esanikezwa, kodwa bagcinwa ejele kwaze kwafika usuku uPhapha ahamba ngalo eCanada, bakhululwa ngaphandle kwencazelo noma ukuxolisa. UGreg uyaqhube ka uthi umbhali walendaba uthi uyazi ukuthi ukusabalaliswa

kwezincwadi ezidalula izimfihi ngenkolo yamaRoma aKhatholika yiso kanye isizathu uTony Alamo ezithola esejele futhi. Iziphathimandla zizama ukuhlela ofakazi bamanga. Uma iziphathimandla zikhathalele ngempela ukuhlukunyeza kwezingane, emzimbeni nangobulili, kungani bengavali zonke izikhungo zamaRoma aKhatholika njengoba sekutholakele futhi kunobufakazi obuqinile ukuthi abantwana, izinkulungwane zabantwana (UGreg unezelwa ngamakhulu ezinkulungwane, izigidi eminyakeni) baye banukubenza ngokocansi nangokomzimba, bahlushwa, futhi baze babulawa abapristi abangashadile? Uyabuza, “Kukangaki uzwa ngompristi obekwe icala yilabo ababadlwengulile kanye nalaba ababahlukumezile, belindele ukwahlulela ngeqiniso, kuphela uthole ukuthi lesikhohlakali sisusiwe sayobekwa kwenye imishini noma kwelinye ibandla ngasese, ukuze siqhubeke nokuhlukumeza kwenye indawo? Kuphi ukulunga, liphi iqiniso? Kungani abazali bamaKhatholika asebazi ngokunukubenza kwabantwana ngabapristi beqhubeka nokuhambisa abantwana babo kulezikohohlakali ezipukile ezigcwele izinkanuko zokunkubeza izingane? Luphi uthando lwabo lwemvelo? Akusikho yini lokhu ukunganakekeli? Bayazi futhi bayafunda ngalezikhohlakali ezinukubeka izingane emaphepheni nsuku zonke. Kungani abasemthethweni bengazikhathazi ngalesisikokela esikhulu sokuhlukunyeza kwabantwana? Kukhona ukuba nxambili, inqubo eyodwa eseka i-Romu, nenyenqubo elawula umhlaba wonke, njengoba kubonakala odabeni lukaTony Alamo.”

UGreg ufunda okuthile okubhalwe yindoda ogama layo nguShane ngo 2009, obiza iDHS ngokuthi yi-Department of Human Suffering – Umnyango woKuhlupheka kuBantu) Wathi iDHS yantshontsha abantwana abangu 35, yabopha uTony Alamo, kanti ngokwenza njalo, yabeke iBhayibheli icala. INkonzo ka-Alamo ayisiyo inkoloze noma ibandla elidaleke ngenxa yoqhekeko (i-sect), kodwa ngumphakathi onokuthula wamaKristu, okholwa yiBhayibheli futhi ozimisele ukushumayela iBhayibheli emhlabeni wonke. Isizathu esingaqondakali futhi esingenamqondo ijaji elasinikeza ngokuthatha lababantwana kubazali babo, ukuthi babengagonywanga futhi ben-gabhalisiwe kuhulumeni njengabantwana abafundiselwa emakhaya. UGreg wabe esethi bangafaka igciwane le-Ebola kumgomu, ngakho qhela kukho konke ukugonywa kanye nokugonyelwa umkhuhlane. Uthi bebelokhu bevala amawebusaythi aphikisana nokugoma. UShane uthi iqiniso ngalokhu kuthunjwa wukuthi izinkonzo zakwa-Alamo zishumayela “IBABILONI ELIKHULU, UNINA WEZIFE BE NOWAMANYALA OMHLABA” (IsAmbulo 17:5).

UGreg uthi isizathu esisodwa sokuthi bamzingele baze bamthole uTony wukuthi unempumelelo enkulu. Inkonzo yakhe inedumela kakhu, futhi umlayezo wakhe wawufinyelela ezinkulungwaneni kanye nakumakhulu ezinkulungwane zabantu. Uma wayehleli endlini yakhe ek-huluma nabantu abawu 20, babengeke bazihluphe ngaye, kodwa abafuni ukuba izimfihi zabo ziphumele obala, futhi ingakho lokhu kwenzekile kuye. Isixazululo sisodwa futhi ukuthi ungakholwa okuzwa emithonjeni yezindaba ngalendaba ngoba abanitshelanga ngokuphoqwa; abanitshelanga ngezinto eziningi. Bamlahla ngecalabasebekhuluma ngalendaba beyibheke ngeso likamshushisi, futhi nanoma yimuphi umuntu owayilalela wayehamba ethi, “Kumele ukuba une-calabase.” Yindlela lena uhulumeni, abezindaba, kanye neVatican abasebenza ngayo ndawonye.
