## **THE CORRUPT BUSINESS OF CHILD PROTECTIVE SERVICES**

In this report, I am focusing on the Georgia Department of Family and Children Services (DFCS). However, I believe Child Protective Services nationwide has become corrupt and that the entire system is broken

almost beyond repair. I am convinced parents and families should be warned of the dangers.

I had witnessed the “Gestapo” at work and I witnessed the deceitful conditions under which children were taken in the middle of the night, out of hospitals, off of school buses, and out of homes.

Parenting classes, anger management classes, counseling referrals, therapy classes and on and on are demanded of parents with no compassion by the system even while they are at work and while their children are separated from them. This can take months or even years and it emotionally devastates both children and parents. Parents are victimized by “the system” that makes a profit for holding children longer and “bonuses” for not returning children. Caseworkers and social workers are oftentimes guilty of fraud. They withhold evidence. They fabricate evidence and they seek to

Just look at the heartbreak and torture in this boy's face because his mother can only visit him for one hour a week. His mother is a Christian and no one has ever abused this child until he was in the care of the Department of Human Services.

Now they have arrested his mother and another parent, Don Thorne, and put them in jail for no good reason—just because they are trying to protect their other children and not turn them over to adoption agencies.

The DHS now says she can't see her children at all because it is too traumatic for the children to see their mother in jail.

terminate parental rights. However, when charges are made against them, the charges are ignored.

The Adoption and Safe Families Act, set in motion by President Bill Clinton, offered cash "bonuses" to the states for every child they adopted out of foster care. In order to receive the "adoption incentive bonuses," local child protective services need more chil-

dren. They must have merchandise (children) that sells and you must have plenty of them so the buyer can choose. Some counties are known to give a \$4,000.00 bonus for each child adopted and an additional \$2,000.00 for a "special needs" child. Employees work to keep the federal dollars flowing.

The National Center on Child Abuse and Neglect in 1998, reported that six times as many children died in foster care than in the general public and that once removed to official "safety," these children

are far more likely to suffer abuse, including sexual molestation than in the general population.

According to the California Little Hoover Commission Report in 2003, 30% to 70% of the children in California group homes do not belong there and should not have been removed from their homes.

The system cannot be trusted. It does not serve the people. It obliterates families and children simply because it has the power to do so.

### BILL OF RIGHTS

#### Article the Third

#### Amendment I

Q: Why are all of these State Assisted Kidnappings Happening?

A: The Clinton Adoption and Safe Families Act (ASFA) of 1997—Rewarded States that increased adoptions with incentive funds—Implemented shorter time limits for making decisions about permanent placements: Permanency hearings to be held no later than 12 months after entering foster care.

States must initiate termination of parental rights proceedings after the child has been in foster care 15 of the previous 22 months.

*"Most of the time, I was taking their kids away for no good reason"—A New York City CPS worker.<sup>1</sup>*

All it takes to begin the potential destruction of a family is a call to one of the child protective "hotlines" in every state. The call can be made anonymously, making the hotlines potent tools for harassment. More often, however, false allegations are well-meaning mistakes made by people who have taken the advice of the child savers.

Though state laws generally encourage—or require—reports if you have "reasonable cause to suspect" maltreatment, child savers

urge us to call in our slightest suspicions about almost any parental behavior. (And that sort of advice is not limited to adults. One group has published a comic book effectively telling children to turn in their parents to "other grown-up friends" if they get a spanking.)<sup>2</sup> The hotlines then forward the calls to Child Protective Services (CPS) agencies who send workers to investigate. These workers can go to a child's school or day care center and interrogate them without warning. Such an interrogation can undercut the bonds of trust essential for healthy parent-child relationships

### Legally Kidnapped: Child "Protective" Services Destroyed My Family

Child protection is one of the biggest businesses in the country. We spend \$12 billion a year on it. The money goes to tens of thousands of state employees, collateral professionals such as lawyers, court personnel, court investigators, evaluators and guardians, judges, and CPS contracted vendors such as counselors, therapists, more evaluators, junk psychologists, residential facilities, foster parents, adoptive parents, MSPCC, Big Brothers/Big Sisters (Big Brothers have been said to be homosexuals and Big Sisters are alleged to

be lesbians), YMCA, etc.

Service providers, called vendors, hold multi-million dollar contracts with CPS. Families are ordered to engage in "services" with these contracted vendors, all of whom bill Medicaid at enormously inflated rates for "services" that are often inappropriate, unnecessary, and completely irrelevant to the families' situation, or to child maltreatment.

Nothing in our life experience is more devastating than the abrupt, brutal, and unwarranted forced separation by strangers. The

## A Critical Look at the Child Welfare System—Interrogation Techniques

Coercive or highly suggestive interrogation techniques can create a significant risk that the interrogation itself will distort the child's recollection of events, thereby undermining the reliability of the statements and subsequent testimony concerning such events.<sup>1</sup>

Threats, bribes, promises of rewards, and other forms of psychological duress are often applied by social workers as they seek disclosure from children.

Promises are often made to children by child protective caseworkers that they will be allowed to leave, and return to their parents, once they "disclose" the alleged abuse.

"Just tell us what happened, and you can go home," and similar phrases

## Adoption Bonuses: The Money Behind the Madness

*Department of Social Services and Affiliates Rewarded for Breaking Up Families*

In this article I explain the financial infrastructure that provides the motivation for DSS to take people's children—and not give them back.

In 1974, Walter Mondale promoted the Child Abuse and Prevention Act which began feeding massive amounts of federal funding to states to set up programs to combat child abuse and neglect. From that came Child "Protective" Services, as we know it today. After the bill passed, Mondale himself expressed concerns that it could be misused. He worried that it could lead states to create a "business" in dealing with children.

Then in 1997, President Clinton passed the "Adoption and Safe Families Act." The public relations campaign promoted it as a way to help abused and neglected children who languished in foster care for years, often being shuffled among dozens of foster homes, never having a real home and family. In a press release from the U.S. Department of Health & Human Services dated November 24, 1999, it refers to "President Clinton's initiative to double by 2002 the number of children in foster care who are adopted or otherwise permanently placed."

parent-child bond is our strongest instinct, superseding all else. To have this bond severed by state agents who possess unhindered power, and give no thought or consideration to the fear, anxiety, and trauma that their actions cause, is a crime against humanity. This is happening to 4,600 children per day, right here in the United States of America.

The law states that a child can only be removed from their home as a last resort, and only when the child is at imminent risk of serious harm, but CPS does not follow established law and policy, and nobody makes them.

Federal statistics say that there are approximately 3 million reports of suspected child abuse and neglect each year. The U.S. Department of Health & Human Services documents 900,000 as "substantiated," leaving over 2 million families per year FALSELY ACCUSED. Of the "substantiated" cases, 68% do NOT involve child maltreatment, according to the federal authorities. This figure is escalating at an alarming rate each year as overzealous reporting and frivolous intervention by CPS spins out of control.

Parenting classes required by the State and weekly psychotherapy sessions through CPS contracted vendors consist of nothing more than coercive persuasion designed to interrogate, break down your will, and cause you to believe the unbelievable. In the end, it's all for nothing. CPS tells you that you're "in denial"

An abused child that will require large amounts of psychological and medical therapy, costing the state large sums, just to become even close to healthy looking enough to bring a profit on the adoption market? Or is it our young, smart, healthy, happy children that will require little care by the state while they house them and then adopt (sell) them out to the foster family that has been getting paid to house them in the first place? Which do you think CPS wants?

Innocent parents don't even get a real day in court once accused. The fact that CPS laws are

constantly being fast tracks to adoption, that they are limiting the times for appeals, as well as the nature of appeals, and that juvenile court has a 100% total lack of rules of evidentiary procedure and there is no chance for a trial by jury, then you don't have a system of child protection. You have a Gestapo carting non-abused children and their innocent parents off to concentration camps of the soul for life.

## American Legal System Is Corrupt Beyond Recognition, Judge Tells Harvard Law School

"The American legal system has been corrupted almost beyond recognition," said Judge Edith Jones of the U.S. Court of Appeals for the Fifth Circuit.

"The integrity of law, its religious roots, its transcendent quality are disappearing. The first 100 years of American lawyers were trained on Blackstone, who wrote that: 'The law of nature dictated by God himself is binding in all counties and at all times; no human laws are of any validity if contrary to this. The Framers created a government of limited power that is dependent on transcendent religious obligation,'" said Jones.

"Having lost sight of the moral and religious foundations of the rule of law, we are vulnerable to the destruction of our freedom."

The judge quoted George Washington who asked in his Farewell Address, "Where is the security for property, for reputation,

for life, if the sense of religious obligation desert the oaths in courts of justice?"

"Natural law is not a prescriptive way to solve problems," Jones said. "It is a way to look at life starting with the Ten Commandments." bye. Cory is now shooting and killing people in play. He has anger problems. Rosy now throws fits. They don't know how to cope with their anger. They were never like this before! I can't do anything to help them.

The foster mother complained about my children, saying, "I just had to tell them they couldn't eat so much. I can't afford it." But they are not big eaters at all. My girls told me they have to beg food from their classmates! They complain of stomach aches and diarrhea a lot. Since being in DHS custody, my once healthy children have had so much sickness with flu, strep throat, diarrhea, vomiting and colds. All my kids have been put on antibiotics and many other medications.

Lily wrote twice that she wants to die. All of my children are suffering horrible nightmares. Ava is so sad that she cries all day in school for me and won't play. Susanna has reddened eyes when we see her because she cries for me. Annie Belle was wearing skull and bones earrings and clothing. They now watch movies with witchcraft, mysticism, nudity, profanity and television. I really don't know what all they watch because they are not allowed to tell us.

The foster mother kept reminding me that kids are adopted out of foster care by a year, no

## CPS and Adoption False Allegations and Federal Adoption Bonuses

In the United States, adoption is big business, bringing in more than \$1.4 billion every year.

Coercion runs rampant in infant adoption, but kidnapping is a better way to describe the tactics employed by Child Protective Services. Federal adoption bonuses have given states overwhelming incentive to remove children from safe and loving homes based on false allegations of child abuse.

Low income families are especially at risk, as they must often depend on a public defender to present their case in court. Homeschoolers, non-vaccinating parents, and others who fall outside the mainstream also make easy targets for CPS.

are in common use today. The desired effect is to elicit disclosure by offering the frightened child a thinly veiled opportunity to end the interrogation. Duress and coercion continue to remain central elements in such investigations, whether delivered by prosecutors, police, therapists or child protective caseworkers.

*Our children were not at all abused. They just took them because they want to close our church down. What do you think they'll do with you and your children if you don't stand up now and be counted for as Tony Alamo and his people are doing?*

later. They especially adopt out the young ones. My kids were being made to feel like they are not wanted by us, by the foster parents.

My kids are forced to see each others' nakedness. My kids are forced to shower together. Annie told me that they screamed and cried when they were made to shower together, but now they don't cry anymore. They are asked to change Cory's diapers.

Now my children have been separated into three different places. Three girls are in a shelter. My 9 year old is alone and my 1 and 2 year old babies are in another place without any older sibling to care and trust in. In the shelter there are no toys. They begged the social worker for just one of their Barbies. She promised to look into it but still no answer. My 9 year old doesn't even know her foster guardians' names, because she says they don't even talk to her. My babies' clothes, hair, and diaper bag reeked of cigarette smoke from their new location. They are now at greater risk because they have been so sick with lung infections since in custody.

My kids were not allowed to keep their Christmas gifts from us. They went away so heartbroken. They were allowed to open them, but not allowed to keep them. I am not allowed to give them their beautiful, warm clothes or toys from home. They must wear filthy, torn, used clothes that don't fit them. They are not being dressed properly for the weather. They have dirty, messy hair that looks terrible. They have dirty fingernails that are always long and cut into their faces. They all look and feel sick and neglected.

The kids were all strip searched. When my girls were told that they would have to see the doctors again to be examined, Lily looked at me with tears in her eyes and said, "Mom, they already did that to me." The DHS tried to drag Lily and Annie to a psychological and physical evaluation while they were burning up with fevers, flu, and strep throat. The foster mother wouldn't let the DHS take them even though they sent a special person to drive up there

from Texarkana to make sure the job got done.

The foster mother ridiculed Lily by saying Lily didn't know much about the Bible when the foster mother questioned Lily about her beliefs. Now their Bibles have been taken away. How can my children stand up against all this? Lily told me that the foster guardian is telling her that we, her parents, are wrong because the Bible doesn't say you have to be perfect, the Bible doesn't say the Vatican is the whore. I said to Lily, "What did Jesus say to the rich man - If you will be perfect...You can believe Jesus, Lily." These people are well trained to destroy the faith in my children. They destroy their proper up-bringing. I can see the changes in all of my children. Now my girls are encouraged to wear make-up and talk about boys and to be subject to things they have never known. It breaks my heart.

I am standing in prayer. If God be for us, who can be against us?

PS. On the day I was taken to court and had my nursing visits with Rosy terminated, the head of the DHS lawyers, Mary Helen Mitchell, said to our lawyer that I "need to be put out in the pasture with the rest of the cows."

Update: The 2 year old son who was always so happy, gentle, and friendly before being taken by the DHS, has drastically changed into a tormented, angry, and terrified child. He used to always love to be cuddled and kissed by his mother. But now at the visits, he is violent with his toys and hits and yells at his mother. At a recent visit when his mother tried to hug and kiss him, he yelled at her, "No Mommy! Don't Mommy!" He would not let her touch him. When she tried to take him to the bathroom to change his diaper, he became hysterical and screamed, "Don't Mommy! Don't Mommy!" He then slapped his mother's face and started crying with terror in his eyes. His mother was able to ask him if someone hurt him to which he said "yeah."

## Former Alamo follower speaks out in support of the preacher

MAGAZINE—A former follower of Tony Alamo is also speaking out in support of the man he says helped turn his life around. Bill Henry says he had lost his little girl, was randomly traveling across the country and drinking heavily. He was given literature from the church and called the prayer line. That's when he moved back and into the ministry's dormitory in Fort Smith. Henry lived there three months during the summer of 2007, until his uncle passed away and he left to attend the funeral and help care for his father.

Henry told 5NEWS his mother commented that he seemed happy at the ministry and was encouraged by another brother to be a witness to his family which he left to do. He says it's hard to believe the charges against his former pastor and the allegations of abuse aimed at parents in the church.

According to Henry, he never saw anything of the sort and believes that people simply don't understand the church.

"I have been told that I was brainwashed while I was in there and all this stuff," Henry said. "But you know I'm in my normal head and I saw a lot of good being done through the Alamo church."

Henry only spoke to Alamo once and that was when he [Henry] had to be taken to the hospital after passing out in church. He says the pastor prayed for him over the phone and when he thanked him, Henry says Alamo told him to 'thank God' and that he [Alamo] didn't get any of the credit. Henry says he was not held hostage and made the decision to leave on his own.

Henry now attends a church in Booneville but would like to visit the Alamo church.

and traumatize children for whom the only harm is the harm of the investigation itself.

Workers can search homes and strip-search children without a warrant. Child savers insist such searches are rare. But in the course of defending against a lawsuit, the Illinois Department of Children and Family Services acknowledged how common they really are. In its legal papers, the department said that any effort to restrict strip-searching “would immediately bring the child abuse hotline investigations to a halt.”<sup>3</sup> Such a statement can be true only if strip-searching is routine.

No proof is required to “substantiate” a case. In most states, “substantiated” means only that there is “some credible evidence” of maltreatment, even if there is more evidence of innocence.

There is a CPS worker who allegedly told several parents, “I have the power of God.”
