

# FAMOUS EX-CONS

“And Joseph was brought down to Egypt; and Potiphar, an officer of Pharaoh, captain of the guard, an Egyptian, bought him of the hands of the Ishmeelites, which had brought him down thither. And the Lord was with Joseph, and he was a prosperous man; and he was in the house of his master the Egyptian. And his master saw that the Lord was with him” (Gen. 39:1-3).

The Lord made all that Joseph did prosper, so his master put all that he had in Joseph’s hands. “The Lord blessed the Egyptian’s house for Joseph’s sake... [both] in the house, and in the field... And Joseph was a goodly person, and [very handsome]” (Gen. 39:3-6). “And it came to pass after these things, that his master’s wife cast her eyes upon Joseph; and she said, Lie with me” (Gen. 39:7). “But he refused and [told her, look,] my master [doesn’t know] what is with me in the house, and he hath committed all that he hath to my hand; There is none greater in this house than I; neither hath he kept back any thing from me but thee, because thou art his wife: how then can I do this great wickedness, and sin against God?” (Gen. 39:8-9).

Day after day, she kept talking to Joseph, but he would not listen to her, to lie with her or to be with her. Then one day Joseph went into the house “And she caught him by his garment, saying, Lie with me: and he

left his garment in her hand, and fled, and got him out” (Gen. 39:10-12).

When she saw that he left his garment and fled, she called the men of the house, and spoke “unto them, saying, See, he hath brought in an Hebrew unto us to mock us; he came in unto me to lie with me, and I cried with a loud voice: And it came to pass, when he heard that I lifted up my voice and cried, that he left his garment with me, and fled, and got him out. And she laid up his garment by her, until his lord came home” (Gen. 39:13-16).

“And she spake unto him according to these words, saying, The Hebrew servant, which thou hast brought unto us, came in unto me to mock me: And it came to pass, as I lifted up my voice and cried, that he left his garment with me, and fled out. And it came to pass, when his master heard the words of his wife, which she spake unto him, saying, After this manner did thy servant to me; that his wrath was kindled” (Gen. 39:17-19). “And Joseph’s master took him, and put him into the prison... and he was [left] there in the prison” twelve years (Gen. 39:20).

This ex-con was falsely convicted of a sex crime and he was put in prison for twelve years,<sup>1</sup> but God delivered him and made him the second in command in Egypt (Gen. 41:39-44). Joseph was made the ruler of Egypt because of the gifts that God had

given him of wisdom and the ability to reveal the mysterious revelation of dreams and visions. With the gift of God to interpret dreams and visions, and his God-given ability to govern, he saved Israel and Egypt. # Child or Adult?

## Childhood

*Webster's* definition of "childhood" is the state or time of being a child; state or time from birth or infancy to puberty or maturity. *Oxford's* definition of "childhood" is the state or stage of life of a child; the time during which one is a child; the time from birth to puberty.

The definition of *Webster's* dictionary for "puberty" is the state or quality of being first capable of begetting or bearing offspring, which is marked by maturing of the reproductive organs, with the onset of menstruation in the female and the development of the secondary sex characteristics in both sexes; the period at which sexual maturity is reached. The age of puberty varies in different climates and environments, being from 13 to 16 in boys and from 11 to 14 in girls, and is commonly designated legally as 14 for boys and 12 for girls.

I Timothy 4:1-3 states, "Now the Spirit speaketh expressly, that in the latter times some shall depart from the faith, giving heed to seducing spirits, and doctrines of devils; Speaking lies in hypocrisy; having their conscience seared with a hot iron; Forbidding to marry."

## Childhood Ends at Puberty

I've mentioned before my contention that childhood ends with puberty and that we do young people a grave injustice by branding them as children until they are 18. Worse, we keep them confined in the world's most ineffective public education system.

Too many young men and women today in their teens who have a genius IQ, are being bored to bad behavior by curricula that have been dumbed down to make sure those with below-average IQ can pass.

Our public education system is a disgrace. It is the most expensive in the world and produces the worst results.

To stretch out for 12 years so little knowledge is ridiculous. Basic education should be finished by the age of 12 or 13. After that, young people should be apprenticed, enrolled in commercial or vocational schools, freed to work. Instead, we, in effect, put off until age 22 when a young person can even get started in a career if it requires a college degree. No wonder the really smart ones drop out.

In the past, childhood ended with puberty, and young men and women were expected to get about the business of life instead of trying to amuse themselves until the age of 18. We would have far less juvenile crime and teen pregnancy if we treated young people as young adults instead of as children. Boredom is the devil's workshop, and I can't think of anything more boring than an American public school.

Education doesn't really take place in an institution. The individual educates himself by reading and thinking. Ideally, a teacher can offer some guidance, perhaps stir some enthusiasm. Most of our public schoolteachers are trapped in an institutional setting where most of their day involves more or less the same duties as a prison guard.

The idea of consolidated central schools is one of the dumbest ones ever to come down the pike, and the field of education is crowded with dumb ideas. Compulsory-attendance laws are another dumb idea. If parents had to face the prospect of living

The state cannot say how many foster children die each year, even though a state law that took effect in 2004, requires counties to release the names, dates of birth, and dates of death for these children. The new law is not being followed by all. It's extraordinarily difficult for the public to learn who in the system is dying and why. The Department of Social Services keeps all names confidential.

with their own children, instead of dumping them into the public school system, they'd make a better effort to teach them good manners. Without compulsory attendance laws, a school could set standards and send home any student who failed to meet them.

### **My Personal Experience In Israel** by Tony Alamo

In Israel, young boys start out working as apprentices in their father's businesses at the early age of five. For example, when I was in Israel, there was a five-year-old boy working in his father's grocery store as an apprentice to learn the grocery business. When a customer would come in and want a certain item that wasn't on the shelf, the father would send his little boy back into the warehouse, and the boy would come back with the item. As a trainee, he was getting acquainted with the inventory so he would be able to train his sons to do the same when he grows up and has children. By the time this boy is 12 years old, he will

have had seven years of experience in the grocery business.

I stayed at a large, modern hotel in Tiberias, Israel, and found out the owner was a young man, 21 years old. He had been the owner of this large hotel since he was 14. The hotel was run with the utmost efficiency. He was very bright, and he spoke almost every language. He greeted the guests in their own language when they came in on tour buses. He was not only running this large hotel, he was managing the dining room and all the other facilities.

In the United States, a boy can't go to work until he is 16 years old. This is sad in that our government keeps children and young adults from growing and gaining responsibility. According to *Webster's* dictionary, childhood is from infancy to puberty. Puberty in a young man is around 14, and in a young woman 12. This means that even though they

## **Free Our Kids**

My name is Greg Pound. Watch a video tape that we are putting together to present the evidence to the people so they can see what's happening here in Pinellas County, FL.

Our daughter was accidentally bit by someone's dog two years ago and the Department of Children and Families came out and took our children from us. I wasn't home. My other three children weren't at home when this incident happened. This CPI agent for the Sheriff's department, Meagan Gallagher, was arrested two months into our case for falsifying 26 cases prior to our case and the removal of our children. Now we've been in this battle for over two years and I've tried everything from going through the whole court system which cost us a whole lot of money and a lot of time.

Our children now have been abused by the Department of Children and Families, Safe Children Coalition to the degree where our children have been in to the doctor over seventy times. My son, four years old, when they took him, he had no cavities. He went to the dentist just a little while ago. He had six cavities, six big cavities. Our children have been isolated from us except for one hour a month. They've done everything they possibly can. It's getting to the degree now where I've decided to come out and to seek petitions from the people. In this past two weeks, I've received over five hundred signatures. What you're going to see on this tape has been done in the past two weeks of people testifying what's happening here in this court system in order to get this second largest federal grant coming into the state of Florida.

Now me and my wife, we don't smoke, we don't drink, we don't do drugs. We live in a four bedroom home, two baths. We're appealing to the people in Pinellas County and those who watch this video

# A Critical Look at the Foster Care System:

## HOW WIDESPREAD A PROBLEM?

One of the most comprehensive surveys of abuse in foster care was conducted in conjunction with a Baltimore lawsuit. Trudy Festinger, head of the Department of Research at the New York University School of Social Work, determined that over 28% of the children in state care had been abused while in the system.

Reviewed cases depicted "a pattern of physical, sexual and emotional abuses" inflicted upon children in the custody of the Baltimore Department.

In Louisiana, a study conducted in conjunction with a civil suit found that 21% of abuse or neglect cases involved foster homes.

Stephen Berzon of the Children's Defense Fund explained the shocking findings of the court before a Congressional subcommittee, saying: "children were physically abused, handcuffed, beaten, chained, and tied up, kept in cages, and overdrugged with psychotropic medication for institutional convenience."

In Missouri, a 1981 study found that 57% of the sample children were placed in foster care settings that put them "at the very least at a high risk of abuse or neglect." A later report issued in 1987 found that 25% of the children in the Missouri sample group had been victims of "abuse or inappropriate punishment."

## SEXUAL ABUSE

A recent class action lawsuit filed on behalf of foster children in the State of Arizona serves well to indicate the extent of sexual abuse of children in state care. The suit alleges that over 500 of an estimated 4,000 foster children, a figure representing at least 12.5% of the state's foster care population, have been sexually abused while in state care.

But the problems associated with foster placements in Arizona are not limited to sexual abuse. During a recent two-year period, one foster child died on average every seven and a half weeks in the state of Arizona. Four of them were reported as having been "viciously beaten to death" by their foster parents.

The sexual abuse of children in government custody would appear to be a particularly widespread problem. In Maryland, a 1992 study found that substantiated allegations of sexual abuse in foster care are four times higher than that found among the general population. In Kentucky, sex abuse in foster care was "all over the newspapers," according to department head Larry Michalczyk.

Perhaps the most significant indicator of the true extent of sexual abuse in foster care was a survey of alumni of what was described as an "exemplary" and "model" program in the Pacific Northwest, argues University professor Richard Wexler. "In this lavishly-funded program

tape to help us to stop this organized crime system in Pinellas County called the Department of Children and Families where they're using people's children for money.

The De La Cruz family in Pinellas County—their boys were raped in their foster homes. There is an article, I believe it was December of 2004, about the De La Cruz children. These boys were molested from family to family to family. They told their case workers and nothing was done. We've confronted our case workers about the abuse our children are going through to no avail. We haven't been able to get anything done through the court system. Mariel Fleming, she turns away from the truth. It's just a real sad situation.

The article about Meagan Gallagher, December 10, 2004, states, "Pinellas County Sheriff's detective arrested one of their investigators Thursday." She was twenty-five years old. Meagan Gallagher also submitted bogus reports. She submitted bogus reports of child abuse and neglect in order to get money for The Department of Children and Families.

You have the Planned Parenthood of the parenting class that we took and this is what they told us to teach our kids at the age of six. At the age of six, we're supposed to teach our children that, "everyone has

sexual thoughts and fantasies and their having them is normal, and there are different types of parent homes, and that sexual identity includes sexual orientation, lesbians, gays, straights, and bisexuals." We've been required by the state of Florida through our case manager to demonstrate that we're teaching this to our kids and we have to demonstrate it to her in order to get our children back.

Then an article from May 24, 2006, says, "A mother here is looking for her son under Department of Children and Families." This is in the *St. Petersburg Times* where her son has disappeared. And what it is, is we're in a lying court system and we're asking people to please help us to get something done about it. If you want to read it, you can get on the archives of the *St. Petersburg Times* newspaper and read the article. It says, "This is the third time that Levi Dillare, nine, has disappeared since being placed in Safe Children Coalition's care." So what we have is another situation where the children are disappearing.

There's scandals going on in the Department of Children and Families and the big question we've had to ask is, Why are they lying and falsifying this documentation against me and my wife? Why are they doing this? And we've come to the conclusion that the purpose is for money. They're making big money by taking our children from us, lying and falsifying documentation.

They put her in jail for two weeks. She hasn't seen her son going on ten weeks. He's ten years old. You'll see the people crying on this DVD, asking people, what can we get done? It's not only me, we've discovered after two years of fighting with the court system trying to defend our rights to our children and all the lies and the falsifying of this court system.

We found out, this is what they said, "We cannot take your children because of abuse or neglect. The only way we can get your children is by you abandoning your children." And that's why they put us through the hell they put us through, is to try to get us to abandon our children. They make it a living hell. You'll see on this DVD where a lady's husband committed suicide just through the trauma of losing their home, losing their kids, just what it cost them in court and this is exactly what this is—it's a money-maker for the people of this court system, for the lawyers. It's just really sad that we have this going on in America and we're asking somebody to please step up and to help us get it stopped.

caseloads were kept low and both workers and foster parents got special training. This was not ordinary foster care, this was Cadillac Foster Care," he explained. In this "exemplary" program, 24% of the girls responding to a survey said they were victims of actual or attempted sexual abuse in the one home in which they had stayed the longest. Significantly, they were not even asked about the other foster homes in which they had stayed.

### SYSTEMWIDE ABUSES

A 1986 survey conducted by the National Foster Care Education Project found that foster children were 10 times more likely to be abused than children among the general population. A follow-up study in 1990 by the same group produced similar results.

The American Civil Liberties Union's Children's Rights Project similarly estimates that a child in the care of the state is ten times more likely to be abused than one in the care of his parents.

The Children's Rights Project has been involved in suits against child welfare systems in the states of Connecticut, Kansas, Louisiana and New Mexico, and the cities of Kansas City, Missouri; Louisville, Milwaukee, and New York City. Says Children's Rights Project attorney Marcia Robinson Lowry: "There are a lot of injuries, a lot of abuse. The most significant thing is the psychological death of so many of these kids. Kids are being destroyed every day, destroyed by a government-funded system set out to help them."

The California-based Little Hoover Commission, in examining the functioning of the foster care system determined: "That children can come to harm—and even die—while supposedly under the protection of foster care, is not in dispute."

### MINIMIZING THE ABUSES

Child welfare departments are rarely forthcoming with information about the actual extent of harm that comes to children in their care. It is largely through audits and case readings associated with legal actions that the actual extent of abuses in the foster care system come to light.

As Hagedorn succinctly explains: "It's

simply too risky for bureaucrats to admit that their agency may not be 'doing good.' The erosion of that myth may lead someone to investigate them or even propose cutting their budgets. But if there is one thing that is riskier for bureaucrats than admitting that their system may not be doing good, it is that it is doing far more harm than good."

### THE QUIET ABUSES

With the high rate of multiple placements that most foster children endure, the possibility that they may experience overt physical or sexual abuse becomes an increasing certainty with each move. Yet even those children who are not subjected to overt physical or sexual abuse in state care often endure conditions tantamount to abuse.

"These beds were created in response to Department of Children and Family Services saying they need more beds," adds Schmiedel. "It's market-driven forces, children as industry." Part of Schmiedel's job is to go through unusual incident reports. "We must get two or three hundred a week," he says, some of which include serious reports of physical and sexual abuse in treatment centers and foster homes. "It's frightening—we don't know which cases are the most serious."

"You see what some parents do to their kids, but then you see what happens to kids who are removed from their homes and put into foster homes... I mean, the stories are grotesque."

Or consider the plight of those foster wards locked in detention in the San Francisco Youth Guidance Center Facility—maintained in small locked cells alongside alleged juvenile offenders who are themselves awaiting adjudication of their cases. A grand jury found the conditions endured by these children to be far worse than that endured by adult criminals in the County prison.

### THE SILENT NEGLECT

The most tragic aspect of all this is that most of the children subjected to the abuses of foster care don't need to be there. And, it is largely *because* the system is flooded with so many children that don't belong in care that these abuses continue to mount.

are young adults, they can't even work as stock clerks or bag boys in grocery stores until they are 16.

It is the Vatican's plan to keep the people in most of the world in ignorance, especially the United States, and to prevent young women from marrying, if they wish, when they reach puberty. The Bible states in I Timothy 4:1-3, "that in the latter times some shall depart from the faith, giving heed to seducing spirits, and doctrines of devils; Speaking lies in hypocrisy; having their conscience seared with a hot iron; Forbidding to marry."
